Micah Bartelme – Board Chairperson. Appointed to the board in 2019. Micah is the founder and CEO of BarStar Group, an entertainment and development investment company focused on hospitality and mixed-use real estate, with properties including several downtown Ann Arbor bars and restaurants. Micah grew up walking to downtown from what is now Water Hill and is a proud Pioneer High graduate. He and his wife Devon have twin daughters.

Elisabeth Berry - Appointed to the board in 2024. Elisabeth is an operations and strategy executive, providing organizational and strategic support to early-stage companies across digital health, and emerging industries. As a c-suite team member with entrepreneurial ventures, she has experience managing operations, quality systems and compliance in highly regulated sectors, participating in both state regulatory compliance and federal regulatory reform efforts. Elisabeth serves on the board of directors for the S3 Collective, and the Young Professionals Board of the Autism Alliance of Michigan. Steve Brummer – Board Treasurer. Appointed to the board in 2022. Steve has been a dedicated public servant since the age of 16.
